TYPES OF COPYING ALLOWED

Under the copying agreement between Copibec and the *Ministère de l'Éducation, de l'Enseignement supérieur et de la Recherche* (MEESR), teaching personnel in preschool, elementary and high school institutions, including adult education centres and professional training centres, are allowed to legally copy excerpts from copyright protected works. The agreement ensures that authors and publishers receive royalties (licence fees) for the use of their works.

Excerpts can be copied from works in the Copibec repertoire (catalogue) in print or digital format. Under certain conditions, you also have permission to display entire works in class. The agreement covers books, magazines, newspapers, encyclopedias, guides, exercise books, etc. published in Quebec and the rest of Canada as well as nearly 30 other countries.

Copying excerpts from works

For **works developed specifically for preschool, elementary or high school education purposes** (teachers' guides, students' textbooks, exercise books, grammar guides and atlases designed specifically for programs of instruction), the **copying** limit is:

- **10% of the work or 25 pages, whichever is less**

These works are specially identified in the Copibec repertoire.

For all **other types of works**, the copying limit is:

- **15% of the work**

Provided you stay within the limits, you can photocopy or scan an excerpt in order to display it on a smartboard (with the option of saving it for the next class after using smartboard tools to work on it with students), make it available

to students on a secure network or email it to students by using a school or school board email address. However, if the excerpt is commercially available in digital format, that version must be purchased.

Digital format excerpts must be accompanied by a clearly visible notice that prohibits students from printing out more than one copy or transmitting the excerpt to anyone else except in the context of communications with the teacher or other students for team projects or participatory work.

IMPORTANT!

The agreement does not allow you to make copies to produce coursepacks or exercise books. This applies to both print and digital format copies.



Displaying entire works in class

WORKS NOT AVAILABLE IN DIGITAL FORMAT

Under the agreement, you can also make **one copy of an entire work** in order to display it on a smartboard if the work is not commercially available in digital format. You are also allowed to **use a document camera to project a work**. In both these cases, a few copies of the original work must be made available to students in the class.

WORKS AVAILABLE IN DIGITAL FORMAT

An entire work that was legitimately acquired in digital format can be displayed using a smartboard. However, in the case of legitimately acquired digital format **works specifically designed for preschool, elementary or high school education purposes**, you are only allowed to project them on a smartboard if **all the students have original versions of the work** or if the **work comes with a publisher's licence** that allows such use.

Making copies in alternative format

The agreement allows you to reproduce an entire work in **large print** or **modify its original colours** for use by students with sensory, physical or neurological disabilities. It is also possible to **modify a legitimately acquired work** so that students can use software or an application to enter their answers or notes directly. If a work is not available in a format that allows optical character recognition software to be used for **speech synthesis**, a digital format copy may be made but you are required to check with Copibec in advance to see if the work can be obtained.

EXCEEDING THE LIMITS

If you want to exceed the limits specified in the copying agreement, **you have to request permission from Copibec** before making the copies. Your school will be billed whenever the limits are exceeded.

NOT EVERYTHING IS COVERED BY THE AGREEMENT

Certain works or categories of works are excluded from the agreement. The exclusions can vary according to the copying format and publisher. It is important to check the Copibec Exclusions List to make sure the work you want to copy is covered by the agreement. If you want to copy an excluded work, you need to contact the copyright owner directly.

A copy of the Exclusions List is available in your school or can be viewed in the Copibec Educator Space at www.copibeceducation.ca/en.

Works in the public domain or other works that can be copied without permission (e.g. works available online under Creative Commons licences) are not subject to the agreement and therefore do not have to be reported to Copibec when they are copied.

DATA COLLECTION

Why?

You have a very important role to play in ensuring that the royalties paid by MEESR are redistributed to the authors and publishers of the works that have actually been copied. When you report your copies, you are telling us who should be paid the royalties we collect. Thanks to Savia, our online copyright licensing and rights management system, all it takes is a few clicks to report your copies!

Has your school been selected to collect data? Your participation is essential... and compulsory. The authors and publishers of the works you use are counting on you!

How?

You will need to sign into your Savia account to indicate whether or not you made any copies during the school year's three reporting periods.

Savia

In the Copibec *Educator Space* at www.copibeceducation.ca/en, click the Savia link in the top right menu to access our online copyright licensing and rights management system.

Do you already have an account? Enter your email and password in the applicable fields.

If you do not have an account, click "Complete the registration process" and follow the steps. In step 2, select your school. Only employees of the school board itself should indicate the school board instead of their individual school.

Did you forget your password? Click "Forgot your password?"

Are you having problems signing in or creating your account? Do you have questions about online reporting? Please feel free to contact us.

Copies reported

If you did not make any copies during the specified period, tick the appropriate box to indicate that you did not reproduce any material that has to be reported. This gives us confirmation that nothing has been forgotten!

If you made copies or displayed works in class, click PAY-PER-USE LICENCES / COPY LOG ENTRIES in the left hand menu and follow the 5 steps to report your copies. You have to complete a copy log entry for each document copied. All the requested information is important and enables us to redistribute royalties to authors and publishers for the use of their works.

Most of the documents used in schools are already listed in the Copibec repertoire. Refer to the book's ISBN number to report your copies quickly and easily.

Copies that do not have to be reported

- **Reproducible material.** However, you have to respect each publisher's copying terms and conditions.
- **Works in SAMUEL.** These works are automatically reported to Copibec when you make your initial request. You therefore do not have to report them again. To access, SAMUEL, go to www.copibecdigital.ca.
- **Material not covered by the copying agreement**, such as:
 - Works in the **public domain**, works on the **Exclusions List** or works whose **reproduction** has been **authorized** directly by the copyright owner or its representative or under commercial agreements that apply to the institution.

Data collection procedures

The designated person in your school will give you more details about the procedures for collecting data.



NAME YOUR SOURCES

You are required to provide bibliographic references on the copied documents distributed to students or kept in your files. By doing so, you will also be recognizing the author's creative work. Bibliographic references include the author's name, publisher's name, complete title of the work, publication date and place, and page numbers copied.

INFORMATION SESSION
