THE LAW IS CLEAR

Canada's Copyright Act protects any original work as soon as it is "fixed in any material form".

This means that no one in an organization may use copyrighted material without the permission of the copyright holder.

3 (1) For the purposes of this Act, copyright, in relation to a work, means the sole right to produce or reproduce the work or any substantial part thereof in any material form whatever, to perform the work or any substantial part thereof in public or, if the work is unpublished, to publish the work or any substantial part thereof, and includes the sole right:

a) to produce, reproduce, perform or publish any translation of the work [...]

It's well understood, for example, that if you use copyrighted music in a TV production, the owner of the copyright must be compensated. The same goes for images, photographs, or videos: you can't use excerpts from TV shows or movies without the approval of their creators.

A word to the wise

This is also true for the written word. Copying, sharing or using copyrighted written material is illegal without the permission of the copyright holder. This includes everything from novels to scholarly articles to technical manuals.

But we know copyright law is very complex and hard to master. Not to mention the time and effort required to locate copyright holders. Also, we often need information immediately if not sooner.
